## Background

Jury service is an important civic responsibility, and the U.S. Constitution guarantees the right to a jury of one's peers. Nondiscrimination protections are an important tool in ensuring that juries are representative of the broader community and to help ensure fairer and more equitable outcomes in the legal system. Currently, [federal law](#) prohibits discrimination against jurors based on their race, religion, sex, and other characteristics, but this law does not explicitly cover such discrimination based on sexual orientation or gender identity. In 2018, the [American Bar Association](#) formally urged governments at all levels to explicitly prohibit discrimination against jurors based on sexual orientation and gender identity. This map shows the status of jury nondiscrimination protections across the country.

## State-by-State Sources & More Detail

### Alabama

- No state jury nondiscrimination law enumerating sexual orientation or gender identity

### Alaska

- No state jury nondiscrimination law enumerating sexual orientation or gender identity
- State is in federal court of appeals district (U.S. Ninth Circuit Court of Appeals) that has ruled that equal protection prohibits jury service discrimination based on sexual orientation. See [SmithKline v. Abbott](#) (2014).

### Arizona

- No state jury nondiscrimination law enumerating sexual orientation or gender identity
  - However, state has [eliminated all peremptory strikes](#)—removing potential jurors without giving a reason—to reduce bias.
- State is in federal court of appeals district (U.S. Ninth Circuit Court of Appeals) that has ruled that equal protection prohibits jury service discrimination based on sexual orientation. See [SmithKline v. Abbott](#) (2014).

### Arkansas

- No state jury nondiscrimination law enumerating sexual orientation or gender identity

### California

- State jury nondiscrimination law covers sexual orientation and gender identity
- See [CA CCP 231.7](#). See also:
  - *People v. Garcia* (2000), California Appellate Court decision prohibiting jury discrimination based on sexual orientation
  - [AB 87](#) (2015, effective January 1, 2016), which [advocates described](#) as adding gender identity protections. AB 87 amended CA CCP 231.5 to refer to [CA GOV 11135](#), which includes sexual orientation and sex, defined in [CA GOV 12926](#) to include gender identity.
  - [AB 3070](#) (2020, effective January 1, 2021) explicitly adding gender identity to the jury nondiscrimination law (CA CCP 231.7)
- State is in federal court of appeals district (U.S. Ninth Circuit Court of Appeals) that has ruled that equal protection prohibits jury service discrimination based on sexual orientation. See [SmithKline v. Abbott](#) (2014).

### Colorado

- State jury nondiscrimination law enumerates sexual orientation and gender identity
- See [C.R.S. 13-71-104](#). [SB200](#) (2008) added sexual orientation, defined to include transgender status. [HB1108](#) (2021) moved gender identity and gender expression out of the definition of sexual orientation and into their own enumerated characteristics throughout state law.

#### Illinois

- State jury nondiscrimination law covers sexual orientation and gender identity
- See SB899 (2017, effective January 1, 2018, creating jury nondiscrimination law), [SB1378](#) (2019, effective January 1, 2020, adding sexual orientation), and [775 ILCS 5/1-103\(O-1\)](#) defining sexual orientation to include gender identity

- No state jury nondiscrimination law enumerating sexual orientation or gender identity

- See [HF 335](#) (2013), [MN §593.32](#), and [MN §363A.03\(44\)](#) defining sexual orientation to include gender identity

#### Mississippi

- No state jury nondiscrimination law enumerating sexual orientation or gender identity

#### New York

- State jury nondiscrimination law covers sexual orientation or gender identity
- See [SB 720](#) (2002, effective January 16, 2003) for sexual orientation and [SB 1047](#) (2019) for gender identity. See also [NY Attorney General website](#) explaining that the 2002 law applies to [the exercise of civil rights](#), which includes jury service. The 2019 law added gender identity to the same areas of law as the 2002 law.
